The Residences of St. Joseph's is made affordable through government grants under the Canada-Ontario Affordable Housing Program. Under this Program, certain income limits are targeted as part of the tenant selection criteria, therefore, income information is required from all applicants in order to verify eligibility. St. Joseph's Housing Corporation Inc. Guelph requires that applicants provide a guarantor in cases where their ability to pay their rent or meet other obligations under their lease is in question.

Guarantors will be required to provide their consent for a credit search in order to verify their ability to act in this capacity for the applicant.

All information collected will be handled in accordance with the Personal Information Protection and Electronic Document Act (PIPEDA) and will be held in the strictest confidence.
